Executive summary

For the year 2014, UNFPA's contraceptive offer is composed by **40 ITEMS**¹ grouped in **9 SUB-CATEGORIES**.

The **total procurement spend** is **\$131,281,741.84 for a total of 927 orders.** The procurement spend has decreased by 14.8% in value and by almost 7% in number of orders since 2013. In 2013 the procurement spend was \$150,775,375.97 for a total of 991 orders.

The ITEM with the highest procurement spend in 2014 was DMPA_DEPO with \$31,827,290.20 in 2014, 24.2% of the total procurement. In the previous year the item with the highest procurement spend was CONDOM 53 STANDARD with \$26,726,454.00 that was equal to 17,7% of the total spend in 2013.

The item with the lowest procurement spend in 2014 was ZINNIA with only \$2,835, equal to 0.002% of the total procurement spend and 0.3% of the total number of orders. In 2013 the item with the lowest procurement spend was s CONDOM 54 STANDARD with only \$3,003.00, equal to 0.002% of the total procurement spend. This item was not procured at all in 2014.

The CATEGORY with the highest procurement spend was INJECTABLE CONTRACEPTIVES with \$45,433,138.60 and 318 orders. This represents 34.6% of the total procurement spend and 34.3% of the total number of orders. SUBDERMAL IMPLANTS is the second category with the highest procurement spend (\$28,842,969.42 and 109 orders). In 2013 the category with the highest procurement spend was SUBDERMAL IMPLANTS with \$49,467,076.28 and 171 orders, this represented 32.8% in terms of procurement spend and 17.3% of the total number of orders.

The CATEGORY with the lowest procurement spend is LUBRICANTS with only \$309,393.63 and 34 orders, this represents 0.2% of the total procurement spend and 3.7% of the number of orders. In 2013 the category with the lowest procurement spend was also LUBRICANTS, with \$406,417.06 and 36 orders, which represented 0.3% of the total procurement spent and 3.6% of the total number of orders issued in 2013.

Injectable contraceptives, with \$45,433,138.60 that is equal to 34.6% of the total procurement spend, is the 1st category in terms of procurement spend and it is composed by 7 ITEMS. In 2014 there has been a 36.5% increase in the procurement of Injectable Contraceptives from 2013.

Subdermal Implants, with \$28,842,969.42 which is equal to 22% of the total procurement spend,, is the 2nd category in terms of procurement spend and it is composed by 2 ITEMs. In 2013 this was the highest spend category but the procurement of subdermal implants has decreased by 42% in the last year.

Male Condoms, with **\$21,318,392.48 that is equal to 16.2% of the total procurement spend**, is the **3rd category in terms of procurement spend** and it is composed by **10 ITEMs**. In 2013 the spend in this category was \$29,639,764.20, meaning a **decrease of 28% from 2013 to 2014**.

Combined Low Dose OC Pills, with \$22,385,895.35 that is equal to 17.05% of the total procurement spend, is the 4th category in terms of procurement spend and it is composed by 4 ITEMs. The procurement of Combined Low Dose OC Pills has increased by 32% since 2013.

Female Condoms, with \$8,196,498.00 that is equal to 6.2% of the total procurement spend, is 5th category in terms of procurement spend and it is composed by 1 ITEM. The procurement of Female Condoms has decreased by 27% since 2013.

Progestagen Only Pills, with \$3,776,509.41 that is equal to 2.9% of the total procurement spend, is the 6th category in terms of procurement spend and it is composed by 2 ITEMs. The procurement of POP has decreased by 30% since 2013.

Intra Uterine Devices, with \$325,060.15 that is equal to 0.2% of the total procurement spend, is the 7th category in terms of procurement spend and it is composed by 4 ITEMs. The procurement of IUDs has decreased by 73% from 2013.

Emergency contraceptives, with a procurement spend of \$693,894.80, 0.5% of the total procurement spend in 2014, is the 8th category in terms of procurement spend and it is composed by 2 ITEMs. The procurement of Emergency Contraceptives has decreased by 22% since 2013.

Lubricants, with \$309.383,63 which represents only 0.2% of the total procurement spend in 2014, is the 9th category in terms of procurement spend. It is composed of **3 ITEMs**, but due to the low procurement spend and to the similarity between the single ITEMs, in this report they are going to be **considered as 1**. The procurement of lubricants has decreased by 24% since 2013.

The country with the highest procurement spend was NIGERIA with a total procurement spend of **\$9,347,203.01** equal to **7.2%** of the total spend in **2014.** In 2013 it was UGANDA with a total procurement spend of \$11,120,573.50, equal to 7.4% of the total spend in 2013.

The country with the lowest procurement was THAILAND, with \$6,184.50, equal to 0.005% of the total procurement. In 2013 it was BANGLADESH, with only \$2,850, equal to 0.002% of the total procurement. We do not see significant changes in the procurement share of the country with the lowest procurement.

In 2014 the region with the highest procurement spend and the highest number of orders was Africa, with \$83,669,436.30 and 518 orders, equal to 63.7% of the procurement spend and 55,9% of the orders. In 2013 the region with the highest procurement spend and the highest number of POs was also FRICA with \$92,062,670.89, equal to 61% of the total procurement spend for 2013 and 496 POs, equal to 50% POs. The procurement in Africa has decreased by 10% in value and by 4.4% in number of orders since 2013.

For the year 2014, PSB STOCK was composed by **3ITEMS** each belonging to a different CATEGORY, **MALE CONDOMS, FEMALE CONDOMS and IUDs**. The total procurement spend for PSB STOCK was **\$5,783,355** that is equal to **4.4% of the total spend in 2014 and 60% less in value than in 2013.**

Total shipments from PSB Stock in 2014 (MC, FC, IUDs, RHKits) were \$12,236,135.73. In 2013 shipments from stock were **for a total** value of \$13,170,318. Shipments from stock have decreased by 7.6% in the last year.

RH Kit 2A, clean delivery Kit for individual use, was the kit that was shipped the most, by value, representing 18,7% of the total shipments of kits by value.

BAYER PHARMA AG is the vendor that received the highest amount of procurement value with \$43,799,750.68 and 319 orders in 2014. This means 33.3% of the total procurement value and 34.4% of the number of POs. This has increased from 2013, where Bayer Pharma was also the vendor with the highest procurement value, with \$33,289,548.49 and 275 orders in 2013 (22.1% of the procurement value and 27.7% of the POs in 2013). Together BAYER PHARMA AG, PFIZER OVERSEAS LLC and MSD B V sum up to \$97,197,741.39, equal to 74.03% of the total procurement in contraceptives in 2014.

Spend analysis

Overview

In the year 2014 UNFPA procured from 40 ITEMS², compared to only 34 in the previous year. UNFPA's contraceptive offer is composed of **9 SUB-CATEGORIES**.








Figure 6: Variation in the total procurement spend by category (2012-2014)

The item with the **highest procurement spend is DMPA_DEPO with \$31,827,290.20 in 2014, 24.2% of the total procurement.** In 2013 the item with the highest procurement spend was CONDOM 53 STANDARD with \$26,726,454.00, equal to 17.7% of the total spend in 2013. In 2014 JADELLE (\$18,008,950.00) was the second item with highest procurement and CONDOM 53 STANDARD (\$17,665,934.46) the third.

The item with the lowest procurement spend in 2014 was ZINNIA with only \$2,835, equal to 0.002% of the total procurement spend and 0.3% of the total number of orders. In 2013 the item with the lowest procurement spend was CONDOM 54 STANDARD with only \$3,003.00, equal to 0.002% of the total procurement spend. This item was not procured at all in 2014.

The ITEM with the highest number of POs was SYRINGESOLO1ML with 147 orders, representing 15,8% of the total procurement orders. DMPA_DEPO (113 orders), CONDOM 53 STANDARD (89 orders) and JADELLE (71 orders) were the following most ordered items. In 2013 the item with the highest number of POs was JADELLE with 125 orders, representing 12.6% of the total procurement orders.

The category with the highest procurement spend was INJECTABLE CONTRACEPTIVES with \$45,433,138.60 and 318 orders. This represents 34.6% of the total procurement spend and 34.3% of the total number of orders. SUBDERMAL IMPLANTS is the second category with the highest procurement spend (\$28,842,969.42 and 109 orders). In 2013 the category with the highest procurement spend was SUBDERMAL IMPLANTS with \$49,467,076.28 and 171 orders, this represented 32.8% in terms of procurement spend and 17.3% of the total number of orders. The procurement of subdermal implants has decreased by 42% in the last year.

The category with the lowest procurement spend is LUBRICANTS with only \$309,393.63 and 34 orders, this represents 0.2% of the total procurement spend and 3.7% of the number of orders. In 2013 the category with the lowest procurement spend was also LUBRICANTS, with \$406,417.06 and 36 orders, which represented 0.3% of the total procurement spent and 3.6% of the total number of orders issued in 2013. The spend in lubricants has, therefore, decreased by more than 30% in the last year.

The category with the highest number of POs was INJECTABLE CONTRACEPTIVES, with 318 orders representing 34.3% of the total number of orders for 2014. In 2013 it was the same category the one with the highest number of POs, INJECTABLE CONTRACEPTIVES, with 275 orders, representing 27.7% of the total orders for 2013. As detailed in the table below, the procurement of injectables has increased since 2013 both in value and in number of POs.

Subdermal Implants

This category, with \$49,467,076.28 which is equal to 22% of the total procurement spend, is the 2nd category in terms of procurement spend and it is composed of 2 ITEMs. In 2013 the spend was \$49,467,076.28 equal to 33.8% of the total procurement spend. The procurement of subdermal implants has decreased by 42% in the last year.

JADELLE, which is procured from BAYER SHERING PHARMA OY, with \$18,008,950.00 is the 2nd item in terms of procurement spend (after DMPA_DEPO). IMPLANON, with \$10,834,019.42 is the 5th item in terms of procurement spend.



