

Procurement undertaken by UNFPA Procurement Services Branch, Copenhagen with no direct UNFPA programme component, at the request and on behalf of third parties (Governments, United Nations Specialized Agencies, inter-governmental organizations, non-governmental organizations, or United Nations entities, including funds, programmes, and subsidiary organs of the United Nations).

#### **Local Procurement**

Procurement undertaken directly by UNFPA country offices, UNFPA regional offices and UNFPA Headquarters.

#### **Inventory Procurement**

Procurement undertaken by UNFPA Procurement Services Branch, Copenhagen for selected Emergency Kits & Reproductive Health Commodities to be held in inventory for UNFPA programmes and customers.


#### **GCCP Inventory**


The Global Contraceptive Commodity Programme (GCCP) is a mechanism that mandates UNFPA to maintain an inventory of key contraceptive related commodities using a revolving fund to strengthen reproductive health programmes, including family planning and sexual health.


#### AccessRH Inventory
